ORDER

Chief General Manager, Rajasthan Telecom Circle, Jaipur is pleased to promote 124 SDEs(T) listed in enclosed Annexure-I locally, purely on temporary basis to officiate in the grade of STS (executives) in IDA pay scale 29100-54500 for a period of not more than 180 days. They will automatically stand reverted on completion of 180 days from the date of issue of this letter or on joining of regular incumbent or by any other orders issued by this office, whichever is earlier. Their pay on local officiating promotion is to be fixed as per provision of FR 22(1)(a)(i). If any SDE has already got IDA upgradation in the pay scale of 29100-54500, his pay on local officiating will be governed as per BSNL executives Time bound promotional policy guidelines issued by BSNL HQ ND No.400-61/2004-Pers.II/308 dated 18.01.2007 and this office letter dated 31.01.2007.

This local officiating promotion does not confer any claim to them for seniority in STS of ITS Gr. 'A' for regularization of the same or for benefit such as seniority etc. in a future date. The competent authority reserves the right to terminate the local officiating promotion without assigning any reason or giving notice etc. to the concerned officers.

In case of any disciplinary/Vigilance case of the type referred in BSNL CO letter No. CVO/BSNL/001/06 dated 12.09.2006 is pending against the officer(s) or any punishment of stoppage of increment is in operation; or the officer(s) is/are on deputation to TCIL etc. the officer(s) should not be promoted without obtaining the specific approval of this office. Information in this regard may be brought to the notice of this office as early as possible.

On promotion these executives are posted in the SSA/Unit shown against each in Annexure-I. The executives who are posted in SSA/Unit other than their present SSA/Unit are transferred as SDE and after joining in new SSA/Unit they are promoted to officiate in STS grade. The SSA heads must ensure the relieving of officer for joining their new assignment on officiating promotion **not later than 20.10.2009** positively and report compliance by FAX. Non-relieving of any officer will be personal responsibility of SSA head.

The SSA Head will ensure that the officers posted to officiate as DE in their SSAs are to be transferred to the stations as SDEs where they are proposed to be posted and then promoted as DE at that station in case they are to be posted to the places other than their present Headquarters.

In case any officer is not willing to accept the officiating promotion, a clear-cut refusal letter may be taken from officer **on or before 20.10.2009** and a consolidated list of such officers along with their refusal letters must be submitted to this office **by 26.10.2009** positively. These officers will be debarred for officiating promotion for one year from the date of issue of this order in accordance with the BSNL HQ letter No.19-27/2002-L&A(Pt.)Pers.II dated 01.07.2004.

The leave, if any, requested by the officer, who has been posted on promotion to different SSA/Unit, should not be granted. He can apply for leave to new Head of SSA/Unit under whom he has been posted only after joining the new post and the new SSA/Unit Head will sanction leave, if it is considered justified in normal course.

Necessary charge report may be furnished to all concerned.
